## **2015 REGISTRATION FORM**

Nā Mokupuni O Lawelawe Lodge of the Order of the Arrow operates under a charter granted by the National Council, Boy Scouts of America and must apply annually for renewal.

Only registered members of the Lodge receive current membership cards authorizing them to purchase special Lodge flaps, OA custom design uniform and equipment items available at the official BSA Scout Shops, and to participate in national and lodge activities including the NOAC, NLS, Section Conclave, Lodge Fellowships, training and banquets.

To register with the lodge OA members need only to complete this form and return it along with <u>their \$15.00</u> annual lodge <u>dues for youth members</u> or \$25.00 for adult members to the council service center.

Youth members must be under 21 years of age when they register to be considered as a youth, otherwise they are considered Adult members.

\*\*\* Lodge members who were inducted during a Fall Ordeal in 2014 do not have to pay dues and register for 2015. Your registration and the dues collected at the 2014 Fall Ordeal were applied to your 2015 annual membership.
